West Virginia Credit Union League

Since its organization over 85 years ago, the WV Credit Union League has evolved into a multifaceted service organization that is ever changing in order to meet the growing needs of its member credit unions. While programs and services have changed over the years, the basic purpose of the League has remained constant -- to further the development and progress of credit unions in the state of West Virginia.

Dues paid by affiliated credit unions provide the funding necessary for the League to operate. In return, credit unions take advantage of the programs and services described below.

Services Provided By the League

Governmental Affairs

At the state and federal level, League staff represent credit unions' interests with members of Congress and their staff. Regulations impacting credit unions are monitored closely. Staff attends America's Credit Union's (ACU's) Annual Governmental Affairs Conference in Washington, DC, and helps raise funds for ACU's Credit Union Legislative Action Council (ACUPAC).

Regulatory Compliance

League staff provide timely information on technical and compliance topics affecting credit unions through compliance workshops, credit union visits, and telephone inquiries. A compliance resource library is maintained at the League office. With the increasing complexity and costs associated with compliance, the League began offering in January 2016 a new online compliance resource, **League InfoSight** via the League's website on a 24/7 basis. This is in addition to **PolicyAid** via ViClarity which provides credit unions online access to over 70 sample policies that can be customized. This service also provides regular communication updates on compliance matters. Both products are dues supported and free to affiliated credit unions.

Technical/Operational Assistance

League staff stay in direct contact with credit unions throughout the state by visits, calls and virtual meetings. League staff provide solutions to operational problems, accounting procedures, interpretation of regulations, and technology issues. Credit unions of all sizes benefit from the expertise and knowledge that League staff have to share.

Education and Training

Each year, a full calendar of educational opportunities, which includes IRA workshops, in-person conferences, webinars, and roundtable discussions, is developed by the League for credit union staff, management and volunteers. League staff attend credit union chapter meetings and activities throughout the state, providing League news, updates, and educational programs. In 2015, the League teamed up with the **Credit Union Webinar Network** to offer various training topics for League member credit union volunteers via the web. The subscription based webinars offer an alternative to those seeking current knowledge, but are constrained by the limitations of travel.

League Award Programs

The Dora Maxwell Social Responsibility Recognition Program for external community service projects is recognized annually. In addition, the League, through its League Designated Fund, annually awards scholarships to ACU's and League sponsored schools. The following awards are recognized at annual meeting: Chapter Leadership, recognizing a chapter member for excellence in chapter service, in 2013 the League Designated Fund established the CUDE scholarship, Credit Union Development and Education, to promote credit unions' social responsibilities and development through education and professional networking. The DE program brings relevance to credit unions' seven cooperative principles and the philosophy of "People Helping People". A credit union volunteer and a paid staff person are awarded the League's highest honors - the William Bryan Hawkins and Pacesetter Awards for their unique contributions to the credit union movement in West Virginia. In 2009, the League Designated Fund established an ACU's Governmental Affairs Conference (GAC) Scholarship. Its purpose is to encourage greater involvement in the political and legislative process. Any employee or volunteer representing a credit union \$50 million in assets or under, and who would be attending the GAC for the first time is eligible to apply.

Public Relations

Keeping credit unions up to date on numerous issues, and the greater public informed through various news media channels on matters affecting their financial well being, involves a daily communications effort by your League. Part of the public relations/mix media relations involves monitoring news while occasionally responding to inquiries from trade and general media outlets. Through these efforts, the League is tasked with shaping the public's image of credit unions as cooperatively owned and democratically controlled financial cooperatives. With a rich history in serving people from all walks of life in a safe and sound manner, credit unions have a compelling story to tell and your League believes it is worth telling often.

Community Involvement

The WV Designated Fund of the National Credit Union Foundation, directed by a local advisory board, is a charitable arm managed by the League for regional or national crisis of impact to the credit union movement. It also funds credit union annual scholarships to ACU's and League sponsored educational opportunities and the Credit Unions for Kids project have benefited from (non-dues) League sponsored activities.

West Virginia Districts

West Virginia is divided into nine districts for the purpose of determining the election of the League Board of Directors. Each district is entitled to a minimum of one director.

Each League affiliated credit union is permitted two votes and may designate two delegates and two alternates to represent the credit union at the League annual meeting.

West Virginia League Chapters

West Virginia League affiliated credit unions are divided into nine local chapters that cover the same geographic regions as the League Districts. Chapters elect boards of directors and hold regular meetings in order to share information, discuss topics of interest, and foster working relationships among credit union peers.

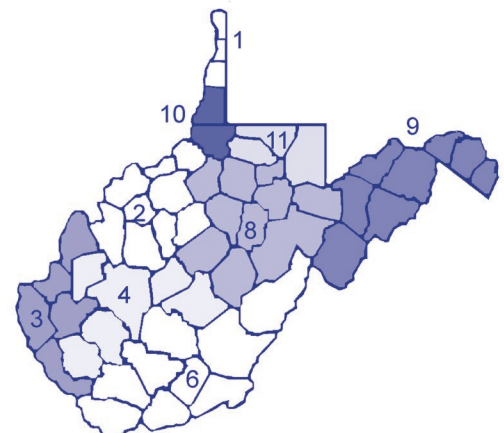

West Virginia League Services Corporation

The LSC works closely with credit unions utilizing endorsed vendor data processing services. This support gives credit unions an accessible resource for questions and problems in addition to the vendor's support service, and enables credit unions to more completely analyze their data processing needs and upgrade their systems when necessary.

Education and Training

The LSC, in partnership with certain endorsed providers offer special training programs to member credit unions and various chapter meeting training sessions.

Supervisory Committee Assistance Program – Audit Services

One of the most popular programs provided by the LSC is that of assisting supervisory committees with their required annual audits. This program works through the Supervisory Committee for both federal and state chartered credit unions and is staffed by individuals well-versed in the operation of credit unions of all sizes. The fee is greatly lower than that of a CPA or accounting firm and provides a much more detailed report for the board to review. LSC staff also provides Automated Clearing House (ACH) Annual Reviews, Bank Secrecy Act (BSA) Annual Reviews, Related Party Account Reviews, Interim Internal Auditing, Surprise Cash Count Verifications, Loan Reviews, Election Ballot Tabulation, Account Verifications (Biannual and Closed Accounts), General Ledger Reconciliations, Internal Control Reviews, Fraud Reviews (Bond Claim Documentation and Forensic Accounting), and change of Key Personnel Reviews.

Product Marketing Assistance

Upon the implementation of new services or already established ones, the LSC can assist credit unions in increasing their share in the market through strategic marketing planning.

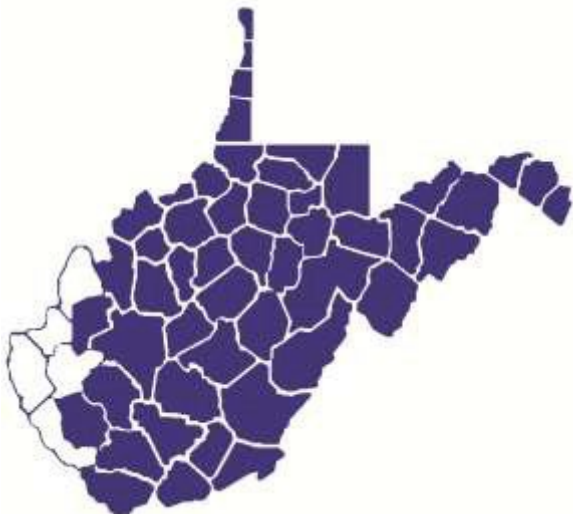
